**ORDER EXTENDING CONTRACT OF FISCAL CONTROL MANAGER
AND SERVICES CONTRACT WITH THE
SCHOOL DISTRICT OF THE CITY OF HIGHLAND PARK**

By the authority of the Local Financial Stability and Choice Act granted under Public Act 436 of the Public Acts of Michigan, 2012, (the "Act") and by the appointment of the Emergency Manager of the District by the Governor of the State of Michigan pursuant to that Act, the following preamble and order is issued:

WHEREAS:

1. Pursuant to Section 12(j) of the Act, this Emergency Manager intends to extend the present Fiscal Control Manager's contract with the Muskegon Heights Public School District through fiscal year 2014/2015.
2. Pursuant to Section 12(y) of the Act, the Emergency Manager intends to extend the Muskegon Heights Public School District's contract with the School District of the City of Highland


Park to provide fiscal control services to the School District of the City of Highland Park concurrent with the Manager's duties with the Muskegon Heights Public School District through fiscal year 2014/2015.

NOW, THEREFORE, BE IT ORDERED THAT:

1. The District shall extend its employment agreement with John Lewis through fiscal year 2014/2015 at the same terms and conditions presently contained in the original contract of employment.

2. The District shall extend its agreement to provide fiscal control manager services to the School District of the City of Highland Park through fiscal year 2014/2015 at the same terms and conditions as presently contained in the parties' "Contract for Services – Fiscal Contract Manager".
